## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's, hand finished, raised 9ct yellow gold & diamond set, three stone ring. Plain, narrow, low half round, tapered band, measures 2.18mm width (at base) x 1.34mm depth, with curved underrail.

Feature, "trilogy style" ring design, with rhodium plated tops illusion claw set, houses three round brilliant cut diamonds, illusion claw set. The extended shoulders, of the band, tapers up to the top, from both sides.



Polished finish, unstamped - acid tested & x-rayed as 9 carat gold.

Finger size Q1/2.

the ring contains;

Three illusion claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 3.36mm (average diameter) x 2.05mm (D-estimated) (smallest)

Dimensions = 4.50mm (average diameter) x 2.75mm (D-estimated) (largest)

Total Weight = 0.69ct (estimated - see NOTE below).

Total Item Weight = 3.30 grams, Total Gemstone Weight = 0.69ct, Total Metal Weight = 3.16 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
