Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.57mm width (at base) x 1.04mm depth, with a hollow top and shoulders, and open back settings.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The top plate is secured to the sweeping decorative underrail, and in between the shoulders of the plain and polished bnad. Each of the shoulders houses three round brilliant cut diamonds, claw set.



Polished finish.

Stamped '750 ISA&C' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G"

Dimensions = 3.91mm(Dia) x 2.39mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Twenty Two claw set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "G to I" (mixed).

Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 2.99 grams Total Gemstone Weight = 0.57ct Total Metal Weight = 2.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
