### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, wide, low half round, tapered band of 4.62mm width (at base) x 1.38mm depth, with closed back settings.

Feature central bezel setting, housing one pear shaped rose cut diamond, bezel set. Surrounding is one row of eighteen round brilliant cut diamonds, bead set. The settings are secured between the tapering shoulders of the plain and polished band.

Polished finish. Stamped '18K 24K unknown makers mark' - acid tested and x-rayed as approximately 18 carat gold. Ring size: N.

The ring contains:

One bezel set pear shaped rose cut diamond, clarity is "P1", colour is "I".

Dimensions = 6.35mm(L) x 5.48mm(W) x 3.34mm(D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below)

Eighteen bead set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 1.01mm(Dia) x 0.62mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 12.76 grams Total Gemstone Weight = 0.59ct Total Metal Weight = 12.64 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
