## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled raised, 18ct white gold & 18ct yellow gold, diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.30mm width (at base) x 1.12mm depth, with curved underrail.

Feature, 'step down cluster' style setting to top, The undercarriage pierced out in yellow gold. The extended shoulders, of the band tapers up to pointed end terminations, from both sides.

Polished finish, stamped "michael hill 750, 0.75" - acid tested as 18 carat gold.

Finger size = Q.

the ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.  
Dimensions = 4.84mm (Diameter) x 2.95mm (D-estimated)  
Total Weight = 0.45ct (estimated - see NOTE below).

Thirty Six bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.  
Dimensions = 1.23mm (average diameter) x 0.75mm (D-estimated) (smallest)  
Dimensions = 1.49mm (average diameter) x 0.91mm (D-estimated) (largest)  
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 4.77 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 4.62 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
