Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, multistone, gem set ring. Plain, narrow, tapered band of 2.91mm in width (at base) x 1.24mm depth, with a curved and split underrail, hollow top and shoulders, and open back settings.

Feature central four claw white gold railed setting, consisting of an illusion plate, housing seven round brilliant cut diamonds, largest to the centre, illusion set. The claw each side having nine round brilliant cut diamonds (smallest), bead set. All secured between the extended shoulders of the yellow gold plain and polished band, each shoulder having six round brilliant cut diamonds, channel set, with eight round brilliant cut diamonds, bead set to each shoulder side.



Polished finish - stamped '375 JP88' - acid tested as 9 carat gold. Finger size is O.

The ring contains:

One illusion set round brilliant cut diamond, clarity 'Vs', colour 'H'.

Dimensions = 3.50mm(Dia) x 2.14mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Eighteen illusion set & channel set (mixed) round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed).

Dimensions (average) = 1.88mm to 1.92mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.45ct (estimated - see NOTE below)

Fifty bead set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed).

Dimensions = 1.05mm(Dia) x 0.64mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 5.02 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
