Valuation for Traditional Retail Replacement

Item 1

One lady's hand-assembled, raised 18ct yellow gold and 18ct white gold "solitaire" diamond ring.

Plain narrow, low half round band, measures 2.03mm wide (at base) x 1.34mm depth, with open back settings.

Feature "solitaire style" ring, houses a Princess cut diamond, set into a white gold, four 'V' shaped claw setting. Upswept extended and pointed shoulders, each contain eight round brilliant cut diamonds, bead set.



Polished finish, stamped 750 - acid tested as 18ct gold.

Finger size M1/2.

The ring contains;

One claw set Princess-cut diamond, clarity is "Vs", colour is "G", medium quality.

Dimensions = 4.15mm(L) x 3.96mm(W) x 2.75mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.40ct (estimated - see NOTE below).

Sixteen bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G, H to I"(mixed), medium quality.

Dimensions = 1.00mm (diameter) x 0.58mm(D-estimated) x 2%(Girdle Thickness)

Dimensions = 1.25mm (diameter) x 0.76mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight= 2.60 grams, Total Gemstone Weight= 0.50ct, Total Metal Weight= 2.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
