### Item 1

One lady's hand crafted plain platinum, diamond set solitaire style ring.

Low half round, parallel 2.63mm in width x 1.20mm in depth shank. Slightly ramped shoulders. Central 4 claw setting housing a round brilliant cut diamond.

Polished finish, stamped " PLATINUM " and acid tested.

Finger size = K

The ring contains:

One round brilliant cut diamond, clarity "Vs2", colour "H", medium to good cut quality.  
Dimensions = 4.78mm(L) x 4.75mm(W) x 2.85mm(D-estimated) x 1.5%(Girdle Thickness)  
Total Weight = 0.40ct (estimated) see NOTE below

Total Item Weight = 4.70 grams  
Total Gemstone Weight = 0.40ct  
Total Metal Weight = 4.62 grams (estimated)
