Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, 'solitaire' style ring, of handassembled construction.

Plain, narrow, low half round, tapered band of 1.71mm width (at base) x 1.01mm depth, with an open back setting, and a curved underrail.

Feature central railed white gold six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail and in between the extended and pointed shoulders. The shoulders are in a 'wrap around' style, and lengthen out of the plain and polished yellow gold band.



Polished finish.

Stamped '750 A&C' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si", colour is "H". Dimensions = 4.22mm(Dia) x 2.70mm(D-estimated) x 4%(Girdle Thickness) Total Weight = 0.31ct (estimated - see NOTE below)

Total Item Weight = 2.66 grams Total Gemstone Weight = 0.31ct Total Metal Weight = 2.60 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
