Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, diamond set, multistone, 'cluster' style ring, of handassembled construction.

Plain, narrow, low half round, tapered band of 1.80mm width (at base) x 1.03mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central square raised top plate, housing four Princess cut diamonds, invisibly set. Surrounding is one row of twenty round brilliant cut diamonds, claw set. The top plate secured to the underrail and in between extended and pointed shoulders, of the plain and polished yellow gold band.



Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: T 1/2.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.37mm(L) x 2.31mm(W) x 1.64mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.24ct (estimated - see NOTE below)

Twenty claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.32mm(Dia) x 0.81mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 3.10 grams Total Gemstone Weight = 0.44ct Total Metal Weight = 3.01 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
