Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold and rhodium plated, articulated, gem set necklet.

Feature central 'cluster' setting, housing one oval cut and faceted natural sapphire, claw set. Surrounded by ten single cut diamonds, also claw set. Articulated between the open back four individual four claw railed settings, each claw set with one oval cut and faceted natural sapphires. Alternating with four hollow and open back, railed 'navette-shape' fittings, finishing with a smaller 'double' hollow and open back, railed 'navette-shape' fittings. All articulated from the flat round 'curb' style linkage design chain, with small 'parrot' type clasp.

Polished finish - stamped '375 A&C' - acid tested as 9 carat gold.

Chain dimensions = 44.50cm (length including clasp) x 1.80mm (width).
Setting dimensions = 5.90mm (length) x 15.00mm (width).

The necklet contains:

Five claw set mixed cut oval shape natural sapphires, colour 'very dark blue'.
Dimensions = 4.25mm(L) x 3.04mm(W) x 1.85mm(D-estimated) (smallest)
Dimensions = 7.04mm(L) x 5.14mm(W) x 3.22mm(D-estimated) (largest)
Total Weight = 1.78ct (estimated - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'H to J' (mixed).
Dimensions (average) = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 6.69 grams - Total Gemstone Weight = 1.88ct - Total Metal Weight = 6.31 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
