Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow and 10ct white gold, multi-stone, ring set, of hand assembled construction.

The set comprising a 10ct yellow gold and 10ct white gold diamond set, fitted and matching wedding and eternity rings. Each ring having a plain, narrow, half round, tapered band with a combined basal width of 4.26mm x 1.09mm in depth.

The fitted and matching wedding and eternity rings are identical. There is one curved row of five white gold shared claw settings, each housing one round brilliant cut diamond, slightly varying in size, and claw set. The settings are secured to the underrail and in between the extended and pointed shoulders, of the plain and polished yellow gold band.



Polished finish. Stamped '10K michael hill 0.25' - acid tested as 9 carat gold. Ring size: R & R1/2.

The rings contain:

Ten claw set round brilliant cut diamonds, clarity is "Si & PI & P2 & P3" (mixed), colour is "G to I" (mixed).

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.72 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.62 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
