Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.40mm in width (at base) x 0.92mm depth, with hollow top and shoulders, and open back settings.

Feature multi-claw ring design, housing five old cut diamonds, tapering in size, claw set. Secured between the extended shoulders of the plain and polished band.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Finger size is P.

The ring contains:

Five claw set old cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed).

Dimensions = 2.75mm(L) x 2.72mm(W) x 1.93mm(D-estimated) (smallest)

Dimensions = 2.94mm(L) x 2.91mm(W) x 2.44mm(D-estimated) (largest)

Total Weight = 0.55ct (estimated - see NOTE below)

Total Item Weight = 3.32 grams

Total Gemstone Weight = 0.55ct

Total Metal Weight = 3.21 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
