## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, pair of hand-assembled, raised 9ct yellow gold,10ct yellow gold & diamond set, squareshaped, stud style earrings.

Feature, "square-shaped" stud style earrings. Each comprising, a four claw railed setting, houses four round brilliant cut diamonds, claw set. The earrings, both with plain post fittings & 10k butterflies attached.

Polished finish, stamped "375 JP02 + 10K" - acid tested.

Earring dimensions = 5.81mm (L) x 5.48mm (W) x 3.04mm (depth).

The earrings contain:

Eight claw set round brilliant cut diamonds, clarity is "P2", colour is "H to I & tinted light brown tint (mixed)", medium cut quality. Dimensions = 2.22mm (average diameter) x 1.35mm (D-estimated)

Total Weight = 0.33ct (estimated - see NOTE below).

Total Item Weight = 1.34 grams, Total Gemstone Weight = 0.33ct, Total Metal Weight = 1.27 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
