Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.90mm width (at base) x 1.02mm depth, with curved underrail, cut out shoulders underneath.

Feature, raised four claw setting, houses one Princess cut diamond, claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder contains five Princess cut diamonds,

Polished finish, stamped "MHJ, 18ct partial" - acid tested as 18 carat gold. Finger size = Q.



The ring contains;

One claw set Princess cut diamond, clarity is "Si", colour is "I", medium cut quality. Dimensions = 4.00mm (L) x 3.86mm (W) x 2.74mm (D-estimated) Total Weight = 0.35ct (estimated - see NOTE below).

Ten channel set Princess cut diamonds, clarity is "Si", colour is "I to J"(mixed), medium cut quality. Average dimensions = 1.60mm (L) x 1.60mm (W) x 1.14mm (D-estimated) Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 4.30 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 4.18 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the germstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
