Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.87mm width (at base) x 1.14mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature marquise shaped top plate, housing thirty-two round brilliant cut diamonds, bead set. The top plate is secured between the extended 'wrap around' style shoulders. Each of the shoulders, has two rows of four round brilliant cut diamonds, graduating in size and channel set. Rhodium plating to the setting areas.



Polished finish. Stamped '375' - acid tested as 9 carat. Ring size: K 1/2.

The ring contains:

- Forty Eight bead set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to J" (mixed).
- Dimensions = 1.25mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 1.89mm(Dia) x 1.15mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.82ct (estimated - see NOTE below)

Total Item Weight = 5.00 grams Total Gemstone Weight = 0.82ct Total Metal Weight = 4.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
