Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 9ct white gold, diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 2.39mm width (at base) x 1.16mm depth, with cut-out underrail.

Feature, "cluster style" ring design. Comprising, three cluster settings across the top, alternates with four cross over motif's & six rub-over side settings, to top. The extended shoulders, of the band tapers up wide to the top, from both sides. With rounded off terminations.

Polished finish, stamped "9K" - acid tested as 9 carat gold. Finger size = P.



The ring contains;

Three claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.48mm (average diameter) x 1.51mm (D-estimated) (smallest)

Dimensions = 2.58mm (average diameter) x 1.57mm (D-estimated) (largest)

Total Weight = 0.18ct (estimated - see NOTE below).

Seventy Four claw set round brilliant cut diamonds, clarity is "P1, P2 & P3" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.14mm (average diameter) x 0.70mm (D-estimated) (smallest)

Dimensions = 1.63mm (average diameter) x 0.99mm (D-estimated) (largest)

Total Weight = 0.82ct (estimated - see NOTE below).

Total Item Weight = 4.90 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 4.70 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
