Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.95mm width (at base) x 1.41mm depth, with open back settings.

Feature five bezel settings, spanning across the top of the band, each housing one round brilliant cut diamond, bezel set. The bezel settings are finished with millegrain detail. Alternating with two round brilliant cut diamonds, bead set.

Polished finish.

Stamped 'PT 950 MHJ 0.33TDW' - acid tested as platinum.

Ring size: I 3/4.

The ring contains:

Five bezel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Twelve bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)



Total Item Weight = 4.23 grams Total Gemstone Weight = 0.33ct Total Metal Weight = 4.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
