Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 14ct yellow gold, gem set earrings.

Feature hollow and hinged, 'hoop' style earring design. Each earring having a single row to the front section, housing four round cut and faceted natural rubies, alternating with two round brilliant cut diamonds, all channel set.

Post fittings, with hinged back arm locking mechanism attached.

Polished finish - stamped '585 & unknown partial stamp' - acid tested as 14 carat gold.

Earring dimensions = 15.44mm (length) x 3.40mm (width).

The earrings contain:

Eight channel set round cut and faceted natural rubies, colour 'medium dark red'.

Dimensions = 2.85mm(Dia) x 1.74mm(D-estimated) (smallest)

Dimensions = 3.20mm(Dia) x 1.95mm(D-estimated) (largest)

Total Weight = 1.08ct (estimated - see NOTE below)

Four channel set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'J to K' (mixed).

Dimensions (average) = 2.80mm(Dia) x 1.71mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.33ct (estimated - see NOTE below)

Total Item Weight = 4.40 grams - Total Gemstone Weight = 1.41ct - Total Metal Weight = 4.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
