Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.98mm width (at base) x 1.54mm depth, with closed back settings, and a curved underrail.

Feature central three claw setting, housing one pear shaped diamond, claw set. Surrounding is two rows with a total of thirty-one round brilliant cut diamonds, claw set. The top plate is supported with a decorative gallery, and is secured in between the 'split' style shoulders of the plain and polished band. Each of the shoulders houses twelve round brilliant cut diamonds, graduating in size, and claw set.



Polished finish. Stamped '375 JP02' - acid tested as 9 carat gold. Ring size: N 1/2.

The ring contains:

One claw set pear shaped diamond, clarity is "P2", colour is "H"

Dimensions = 4.65mm(L) x 2.90mm(W) x 1.77mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Fifty Five claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 3.47 grams Total Gemstone Weight = 0.56ct Total Metal Weight = 3.36 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
