## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of, 18ct white gold, gem set, stud earrings, of hand-assembled construction.

Feature railed four claw settings, each housing one round brilliant cut diamond, claw set The earrings are finished with threaded posts and butterflies.

Earring dimensions = 6.20mm (ave. length) x 6.17mm (ave. width) x 4.08mm (ave. depth).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The earrings contains:

Two claw set round brilliant cut diamonds, clarity is "P1", colour is "G to H" (mixed).

Dimensions = 4.80mm(Dia) x 3.10mm(D-estimated) x 1%(Girdle Thickness) (smallest)

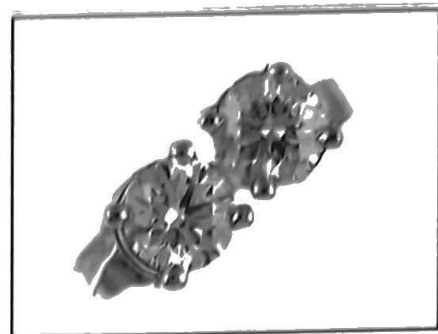
Dimensions = 4.91mm(Dia) x 3.15mm(D-estimated) x 1%(Girdle Thickness) (largest)

Total Weight = 0.86ct (estimated - see NOTE below)

Total Item Weight = 2.00 grams

Total Gemstone Weight = 0.86ct

Total Metal Weight = 1.83 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
