Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.92mm width (at base) x 1.57mm depth, with open back settings.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the plain and polished band. Each of the shoulders houses one row of eight round brilliant cut diamonds, bead set.

Polished finish.

Stamped '950 illegible stamp' - acid tested as platinum.

Ring size: J 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 5.75mm(L) x 5.74mm(W) x 3.50mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.72ct (estimated - see NOTE below)

Sixteen bead set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 1.24mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 3.95 grams Total Gemstone Weight = 0.86ct Total Metal Weight = 3.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
