Valuation for Traditional Retail Insurance Replacement

Item I

One, 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.19mm width (at base) x 1.32mm depth, open back settings, and a curved underrail.

Feature three central clusters, spanning across the top of the band, each within a four claw setting. The settings are secured to the underrail, and in between the extended and pointed shoulders of the plain and polished band. Each of the shoulders houses one row of graduating round brilliant cut diamonds, channel set. There a total of thirty-six round brilliant cut diamonds.



Polished finish. Stamped '375 JP88' - acid tested as 9 carat gold. Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "J".

Dimensions = 3.60mm(Dia) x 2.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.17ct (estimated - see NOTE below)

Thirty Five claw and channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to K" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.79mm(Dia) x 1.70mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.58ct (estimated - see NOTE below)

Total Item Weight = 4.03 grams Total Gemstone Weight = 0.75ct Total Metal Weight = 3.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
