Valuation for Traditional Retail Insurance Replacement

One, 10ct white gold flexible link bracelet, of hand-assembled construction.

Feature one row of articulated four claw settings, each housing one round brilliant cut diamond, varying in size, and claw set. The bracelet is finished with a box clasp, and a figure 8 safety catch.

Bracelet dimensions = 18.50cm (ave. length) x 2.30mm (ave. width) x 2.72mm (ave. depth).

Polished finish.

Stamped '10K MHJ 2.00 TDW' - acid tested as approximately as 10 carat gold.

The bracelet contains:

Eighty claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.05mm(Dia) x 1.25mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 2.00ct (estimated - see NOTE below)

Total Item Weight = 8.10 grams Total Gemstone Weight = 2.00ct Total Metal Weight = 7.70 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
