Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.90mm width (at base) x 1.21mm depth, with open back settings, and a curved cut out underrail.

Feature central row of twenty-one baguette cut diamonds, graduating in size, largest to the centre, and two outer rows of fifteen round brilliant cut diamonds. The rows span across the top of the band, and all the diamonds, are channel set. The settings are secured between the tapering shoulders of the plain and polished band.

Polished finish.

Stamped '750 E' - acid tested as 18 carat gold.

Ring size: P 1/2.

The ring contains:

Twenty One channel set baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 3.00mm(L) x 1.30mm(W) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.50mm(L) x 1.60mm(W) x 1.17mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.78ct (estimated - see NOTE below)

Thirty channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.44mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 7.78 grams Total Gemstone Weight = 1.20ct Total Metal Weight = 7.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
