Valuation for Traditional Retail Insurance Replacement

Item I

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 3.01mm width (at base) x 1.26mm depth, with open back settings.

Feature three central white gold, sweeping four claw settings, graduating is size, largest to the centre. Each setting houses one round brilliant cut diamond, claw set. The settings are secured between the extended and square shoulders, of the plain and polished yellow gold band



Polished finish.

Stamped '750 L&P 2 illegible stamps' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 4.72mm(Dia) x 2.88mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.40ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Si & P1", colour is "G to H" (mixed).

Dimensions (average) = 4.50mm(Dia) x 2.75mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.62ct (estimated - see NOTE below)

Total Item Weight = 4.77 grams Total Gemstone Weight = 1.02ct Total Metal Weight = 4.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
