Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 2.26mm width (at base) x 0.97mm depth, with a curved underrail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band. Each of the shoulders houses one row of seven round brilliant cut diamonds, claw set.

Polished finish.

Stamped '750 CG' - acid tested 18 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "light brown tint".

Dimensions = 4.47mm(Dia) x 2.90mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Fourteen channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "light brown tint".

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 3.24 grams Total Gemstone Weight = 0.53ct Total Metal Weight = 3.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
