## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled raised, 9ct yellow gold & diamond set, flexible link pendant/necklet.

Feature: "cluster style" pendant/necklet. Comprising, an illusion claw set round cluster with a fixed v-shaped bail to top. Suspended from an ultra fine curb link chain, with a bolt ring clasp, attached one end.

Polished finish, stamped "375" - acid tested as 9 carat gold.

Pendant/necklet dimensions = 43.00cm (total length) x 0.57-7.00mm (width) x 0.57-3.10 mm (depth).

The necklet/pendant contains:

- Nine illusion claw set round brilliant cut diamonds, clarity is "P1, P2 & P3"(mixed), colour is "I to J"(mixed), medium cut quality.
- Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated) (smallest)
- Dimensions = 2.60mm (average diameter) x 1.59mm (D-estimated) (largest)
- Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 2.03 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 1.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant/necklet, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
