Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-assembled 9ct yellow gold & diamond set, drop style, open heart shaped pendant.

Featur, "drop style" open heart shaped pendant. Comprising, a channel setting, houses fifteen round brilliant cut diamonds, tapering sizes, channel set. Suspended from a fixed v-shaped bail to top.

Polished finish, stamped "9ct 375" - acid tested as 9 carat gold.

Pendant dimensions = 17.80mm (length) x 13.66mm (width) x 3.07mm (depth).

The pendant contains:

Fifteen channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "brown tint", medium cut quality.

Dimensions = 1.28mm (average diameter) x 0.78mm (D-estimated) (smallest)

Dimensions = 1.74mm (average diameter) x 1.06mm (D-estimated) (largest)

Total Weight = 0.23ct (estimated - see NOTE below).

Total Item Weight = 1.40 grams, Total Gemstone Weight = 0.23ct, Total Metal Weight = 1.36 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
