Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished raised, 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.84mm width (at base) x 1.09mm depth, with curved underrail.

Feature; "solitaire style" ring design, with shoulder stones. Comprising, a raised rub-over setting to centre, houses one round brilliant cut diamond, rub-over set. The extended shoulders, of the band tapers up each shoulder terminates with a roll-over channel collar, each containing five baguette cut diamonds, channel set, both sides.



Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = G1/2.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.
Dimensions = 3.50mm (Diameter) x 2.14mm (D-estimated)
Total Weight = 0.16ct (estimated - see NOTE below).

Ten channel set baguette cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.50mm (L) x 1.10mm (W) x 0.80mm (D-estimated)
Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 2.66 grams, Total Gemstone Weight = 0.28ct, Total Metal Weight = 2.60 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
