## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct yellow gold & gemstone set, cluster ring. Plain, narrow, half round, tapered band, measures 1.95mm width (at base) x 1.29mm depth, with cut-out underrail.

Feature; 'cluster style" ring design. Comprising, a raised rub-over setting to centre, houses one near round cultured pearl, end drilled & glue set. Drops to a surround, containing 9 x old European cut diamonds, calw set. The extended shoulders, of the band, tapers up to the top, from both sides.



Polished finish, stamped "18ct, H.BRIGHT" - acid tested as 18 carat gold. Finger size = O.

The ring contains;

One end-drilled & glued, semi-round cultured white/pink pearl, lustre is "High-Medium", blemish is "Few blemishes".

Dimensions = 4.44mm (diameter) (estimated - see NOTE below).

Nine claw set Old European cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.21mm (average diameter) x 1.44mm (D-estimated)

Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 3.67 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 3.59 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing old for new brilliant cut diamonds, similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
