Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 10ct yellow gold & diamond set, three stone ring, of cast construction. Plain, narrow, half round, tapered band, measures 1.79mm width (at base) x 1.01mm depth, with curved underrail, open back settings, underneath.

Feature, triple claw setting, runs across the top of the band, housing three square cut faceted, diamonds. The extended shoulders, of the band, tapers up, with double roll-over end terminations, to both sides.

Polished finish, stamped "10K' - acid tested approximately 10 carat gold.

Finger size = N.

the ring contains;

Three claw set square cut diamonds, clarity is "Si & P1" (mixed), colour is "light brown tint", medium cut quality. Dimensions = 3.00mm (L) x 3.00mm (W) x 2.13mm (D-estimated)

Total Weight = 0.46ct (estimated - see NOTE below).

Total Item Weight = 1.65 grams, Total Gemstone Weight = 0.46ct, Total Metal Weight = 1.56 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
