## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished, raised 14ct white gold & gemset, cluster ring, of cast construction.

Plain, narrow, low half round, tapered band, measures, 1.78mm width (at base) x 1.13mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising, a pear-shaped, step down cluster setting to top, open back underneath, claw & bead set. The extended shoulders, of the band, tapers up to the top, with a cross over undercarriage.

Polished finish, stamped "585" - acid tested as 14 carat gold. Finger size = M+.

The ring contains;

One claw set pear-shaped, natural sapphire, colour is "extremely light blue".

Dimensions = 7.00mm (L) x 5.00mm (W) x 3.05mm (D-estimated)

Total Weight = 0.75ct (estimated - see NOTE below).

Eighteen bead set round brilliant cut diamonds, clarity is "P1 to P3"(mixed), colour is "H to J"(mixed), medium cut quality.

Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)

Dimensions = 1.20mm (average diameter) x 0.73mm (D-estimated) (largest)

Total Weight = 0.11ct (estimated - see NOTE below).

Total Item Weight = 2.17 grams, Total Gemstone Weight = 0.86ct, Total Metal Weight = 2.00 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
