Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished raised, 9ct yellow gold & diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 2.87mm width (at base) x 0.78mm depth, with curved underrail, hollowed out open back settings, underneath.

Feature, wide pave set top, rhodium plated, to highlight. The extended shoulders, of the band, tapers up wide to the top, from both sides.

Polished finish, stamped "375" - acid tested as 9 carat gold.

Finger size = O.

The ring contains;

Forty Four pave set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed & light brown tint), medium cut quality.

Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 2.93 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.83 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
