### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand finished raised 14ct white gold & diamond set, cluster ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 1.77mm width (at base) x 0.91mm depth, with cut-out underrail, cut out shoulder underneath.

Feature, "cluster style" ring design. Comprising, a raised four claw illusion setting, to centre, houses one round brilliant cut diamond, illusion claw set. Drops to a surround, containing fourteen round brilliant cut diamonds bead. The extended shoulders, of the band tapers up to the top, from both sides.

Polished finish, unstamped - acid tested as 14 carat gold.

Finger size = L.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 4.29mm (average diameter) x 2.62mm (D-estimated)

Total Weight = 0.29ct (estimated - see NOTE below).

Fourteen bead set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.59mm (average diameter) x 0.97mm (D-estimated)

Total Weight = 0.21ct (estimated - see NOTE below).

Total Item Weight = 2.52 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.42 grams (estimated).

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
