## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's raised, 9ct yellow gold, multistone ring, wide, low half round, tapered band, measures 3.09mm width (at base) x 0.95mm depth, with cut-out underrail, open back settings underneath.

Feature, "triple channel rows" across the top, Centre row contains nine round brilliant cut diamonds, channel set. The two outer rows containing a total of seventy four baguette cut & tapered baguette cut diamonds (mixed) all channel set. The extended shoulders, of the band, tapers up wide to the top, from both sides.



Polished finish, unstamped - acid tested as 9 carat gold. Finger size = Q.

The ring contains;

Nine channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "light brown tint", medium cut quality.  
Dimensions = 2.77mm (average diameter) x 1.69mm (D-estimated)  
Total Weight = 0.63ct (estimated - see NOTE below).

Seventy Four channel set baguette cu & tapered baguette cut diamonds (mixed), clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Average dimensions = 1.40mm (L) x 0.70mm (W) x 0.51mm (D-estimated)  
Total Weight = 0.37ct (estimated - see NOTE below).

Total Item Weight = 3.55 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 3.35 grams (estimated)

NOTE: Limited gemmological testing inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
