Valuation for Traditional Retail Insurance Replacement

Item 1



One, hand crafted, 18ct yellow gold and 18ct white gold, multistone, gem set ring.

Plain, wide, tapered band of 11.30mm at top to 6.02mm in width (at base) x 0.84mm depth, with open back settings.

Feature raised 'infinity' style setting, housing two pear-shape peridot, rub-over set. Surrounded by nineteen round brilliant cut diamonds, tapering in size to the centre, bead set. Mounted atop the plain and polished band.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is Q 1/2.

The ring contains:

Two rub over set mixed cut pear shape peridots, colour 'medium dark green'.

Dimensions = 7.06mm(L) x 4.60mm(W) x 3.50mm(D-estimated)

Total Weight = 1.52ct (estimated - see NOTE below)

Nineteen bead set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 13.10 grams - Total Gemstone Weight = 1.94ct - Total Metal Weight = 12.71 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
