Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-assembled raised, 18ct yellow gold & platinum, diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.81mm width (at base) x 1.39mm depth, with curved underrail.

Feature, "solitaire style, with shoulder stones. Comprising, a raised four claw setting, houses one round brilliant cut diamond, claw set. The extended shoulders, taper up to the top, from both sides. Each shoulder having a square shaped, step down settings, housing four single cut diamonds, claw set.

Polished finish, stamped "18ct Plat AD102" - acid tested as 18 carat gold.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.
Dimensions = 4.18mm (Diameter) x 2.36mm (D-estimated)
Total Weight = 0.25ct (estimated - see NOTE below).

Four bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.
Dimensions = 1.43mm (average diameter)
Total Weight = 0.05ct (estimated - see NOTE below).

Total Item Weight = 3.10 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 3.04 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar material and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
