## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand crafted raised, 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.98mm width (at base) x 1.84mm depth, tapers up to 3.10mm width (at top), with curved underrail, open back to settings, underneath.

Feature, "single row" runs across the top of the band, housing six baguette cut diamonds (one chipped), channel set. The extended shoulders, of the band tapers up wide at the top, from both sides.

Polished finish, stamped "750 FJ" - acid tested as 18 carat gold.

Finger size = J.

The ring contains;

- Six channel set baguette diamonds, clarity is "Vs2 & P1", colour is "G/ H"(inset), medium cut quality.
- Average dimensions = 2.80mm (length) x 1.60mm (width) x 1.17mm (D-estimated)
- Total Weight = 0.35ct (estimated - see NOTE below).

Total Item Weight = 4.50 grams, Total Gemstone Weight = 0.35ct, Total Metal Weight = 4.43 grams (estimated)

NOTE: Limited gemmological testing, inset. One of the baguette cut diamonds, has a chip or external fracture visible. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
