## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand-assembled raised, sterling silver & 9ct white gold (mixed), diamond set, solitaire style ring. Plain, narrow, low half round, tapered band, measures 1.84mm width (at base) x 0.87mm depth, with cut-out underrail.

Feature, "solitaire style" ring, comprising, a raised six claw setting, of white gold, houses one round brilliant cut diamond, claw set. The extended shoulders, of the silver band tapers up to the white gold setting, each shoulder, having split leaf shaped terminations to both sides.

Polished finish, unstamped - acid tested & x-rayed as silver & 9 carat gold (mixed).

Finger size = Q.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si2", colour is "H", medium cut quality.  
Dimensions = 4.04mm (Diameter) x 2.33mm (D-estimated)  
Total Weight = 0.23ct (estimated - see NOTE below).

Total Item Weight = 1.90 grams, Total Gemstone Weight = 0.23ct, Total Metal Weight = 1.85 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
