Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished raised 9ct yellow and white gold & diamond set, multistone ring, of cast construction. Plain, wide, half round band, measures 5.63mm width (at base) x 1.64mm depth, with curved underrail.

Feature, "dress style" ring design. Comprising, a raised, two tone band with a wave channel setting, through the centre top, housing ten round brilliant cut diamonds, channel set. The extended shoulders, of the two tone band, tapers up wide to the top, from both sides.

Polished finish, stamped "375 MM" - acid tested as 9 carat gold.

Finger size = R.

The ring contains;

Ten channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality. Dimensions = 1.45mm (average diameter) x 0.88mm (D-estimated)

Total Weight = 0.11ct (estimated - see NOTE below).

Total Item Weight = 8.70 grams, Total Gemstone Weight = 0.11ct, Total Metal Weight = 8.68 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
