Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct yellow gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures, 2.15mm width (at base) x 1.12mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising a raised end set setting, houses one round brilliant cut diamond, end set. The extended shoulders, of the band tapers up & crosses to form the end setting ontop, from both sides.



Polished finish, unstamped - acid tested as 18 carat gold.

Finger size = N.

the ring contains;

One end set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.

Dimensions = 3.96mm (Diameter) x 2.42mm (D-estimated)

Total Weight = 0.23ct (estimated - see NOTE below).

Total Item Weight = 4.50 grams, Total Gemstone Weight = 0.23ct, Total Metal Weight = 4.45 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
