## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, diamond set, two stone ring. Plain, narrow, low half round, tapered band, measures 1.38mm width (at base) x 0.66mm depth, with curved underrail.

Feature, "duo style" ring design. Comprising, a raised four claw setting in white gold to centre. Houses one round brilliant cut diamond, claw set. Drops to one side, a white fold four claw setting, housing, one round brilliant cut diamond, claw set. The extended shoulders, of the yellow gold band, tapers up, with one shoulder sweeping, a wrap around from one side.



Polished finish, unstamped - acid tested as 18 carat gold. Finger size = Q1/2.

the ring contains;

One claw set round brilliant cut diamond, clarity is "Vs", colour is "H", medium cut quality.

Dimensions = 3.71mm (Diameter) x 2.26mm (D-estimated)

Total Weight = 0.19ct (estimated - see NOTE below).

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 1.68mm (Diameter) x 0.98mm (D-estimated)

Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 1.70 grams, Total Gemstone Weight = 0.21ct, Total Metal Weight = 1.66 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the germstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
