Valuation for Traditional Retail Insurance Replacement

Item 1

One gents, raised 14ct white gold & diamond set, multistone ring, of cast construction. Plain, wide, flat, tapered band, measures, 3.57mm width (at base) x 0.80mm depth, with open back, underneath.

Feature, "dress style" ring design. Comprising, a raised square-shaped top, housing to centre one round brilliant cut diamonds, claw set. To each corner, a triangular bead settings, contain four round brilliant cut diamonds, bead set. The extended shoulders, of the band, tapers up wide to the top, from both sides.

Polished finish, stamped "14K, 585" - acid tested as 14 carat gold. Finger size = X.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "I", medium cut quality.
Dimensions = 3.99mm (Diameter) x 2.43mm (D-estimated)
Total Weight = 0.24ct (estimated - see NOTE below).

Four bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 2.12mm (average diameter) x 1.29mm (D-estimated)
Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 8.23 grams, Total Gemstone Weight = 0.38ct, Total Metal Weight = 8.15 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
