Valuation for Traditional Retail Insurance Replacement

Item 1

One pair, of lady's hand-assembled raised, round 9et yellow gold & diamond set, stud earrings.

Feature, "cluster style" ring design. Each comprising, a raised illusion claw setting, rhodiumplated to highlight, contains seven round brilliant cut diamonds, illusion claw set. Drops to a surround, containing twenty round brilliant cut diamonds, claw set. The studs are pierced out wall of the sides & back. Both earrings, with plain post & butterfly disk fitted & attached.



Polished finish, stamped "9K, 0.50ct" - acid tested as 9 carat gold.

Earring dimensions = 10.26mm (width) x 5.20mm (depth).

The earrings contain:

Fourteen illusion claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality. Dimensions = 1.53mm (average diameter) x 0.93mm (D-estimated)

Total Weight = 0.18ct (estimated - see NOTE below).

Forty claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.10mm (average diameter) x 0.59mm (D-estimated)

Total Weight = 0.32ct (estimated - see NOTE below).

Total Item Weight = 3.01 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.91 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the germstones cannot be ascertained Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of cluster style earrings, employing similar materials and techniques being for a retail insurance purpose only.
