Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone ring, of handmade construction.

Plain, narrow, flat band of 2.28mm width (at base) x 1.56mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail of the plain and polished band. Each of the shoulders house one row of five round brilliant cut diamonds, claw set.

Polished finish.

Stamped '750' - acid tested 18 carat gold.

Ring size: J 1/2.

The ring contains:

One claw set Princess cut diamond, clarity is "Si2", colour is "E".

Dimensions = 5.55mm(L) x 5.44mm(W) x 4.05mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 1.00ct (known weight - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity is "Si", colour is "G".

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 4.18 grams Total Gemstone Weight = 1.20ct Total Metal Weight = 3.94 grams (estimated)



NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 2146908295 Dated April12, 2013. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2146908295. Due to setting constraints the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
