## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of, 14ct white gold, gem set, drop stud earrings, of hand-assembled construction.

Feature articulated three piece earrings, 'knot' design stud top, housing twelve round brilliant cut diamonds, bead set. To the bottom is one four claw setting, housing one round brilliant cut diamond, claw set, and one freshwater pearl, cup set. The earrings are finished with post and butterfly findings.

Earring dimensions = 23.32mm (ave. length) x 7.64mm (ave. width) x 2.56mm (ave. depth).

Polished finish.

Stamped '585 115' - acid tested as 14 carat gold.

The earrings contain:

Two end-drilled round cultured freshwater pearls, colour is "black".

Dimensions (average) = 6.33mm (diameter)

Twenty Six claw and bead set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to I" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 3.03 grams Total Gemstone Weight = 0.16ct Total Metal Weight = 3.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
