Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 3.98mm width (at base) x 0.53mm depth, with open back settings.

Feature central raised six claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of eight round natural sapphires, claw set. The top plate is secured between the 'split' style shoulders of the plain and polished band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: X.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.85mm(L) x 3.80mm(W) x 2.32mm(D-estimated) x 2.5%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Eight claw set round natural sapphires, colour is "blue".

Dimensions = 2.77mm(Dia) x 1.69mm(D-estimated) (smallest)

Dimensions = 2.93mm(Dia) x 1.79mm(D-estimated) (largest)

Total Weight = 0.88ct (estimated - see NOTE below)

Total Item Weight = 4.48 grams Total Gemstone Weight = 1.09ct Total Metal Weight = 4.26 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
