One, hand-assembled, 9ct yellow gold and 9ct white gold, multistone ring, narrow, tapered band of 1.70mm in width (at base) x 1.42mm depth, with curved underrail and hollow shoulders.

Feature central white gold four claw setting, consisting of an illusion plate, housing seven round brilliant cut diamonds, largest to the centre, illusion set. All secured between the extended shoulders of the yellow gold plain and polished band.



Polished finish.

Stamped '375 JP14 1' - acid tested as approximately 9 carat gold.

Seven illusion set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H to I' (mixed).

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.05mm(Dia) x 1.25mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 2.00 grams

Total Gemstone Weight = 0.15ct
