Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, wide, tapered band of 4.50mm in width (at base) x 1.17mm depth, with curved and pierced decorative underrail.

Feature central row housing five round brilliant cut diamonds, tapering in size, bar set. To either side is a single row of eight round brilliant cut diamonds, also tapering in size and claw set. All secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'C750' - acid tested as 18 carat gold.

Finger size is O 1/2.

The ring contains:

- Twenty One bar set & claw set (mixed) round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).
Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 3.60mm(Dia) x 2.20mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 2.30ct (estimated - see NOTE below)

Total Item Weight = 10.52 grams - Total Gemstone Weight = 2.30ct - Total Metal Weight = 10.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
