## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 10ct white gold, multistone, gem set ring.

Plain, wide, tapered band of 7.20mm at top to 3.10mm in width (at base) x 0.96mm depth, with hollow top and shoulders, and open back settings, with a curved and pierced, 'lattice' style underrail.

Feature raised central row with a 'satin' finish, housing nine round brilliant cut diamonds, tapering in size, channel set. Mounted atop the plain and polished band.

Polished finish.

Stamped '10K michael hill 0.15TDW' - acid tested as approximately 10 carat gold. Finger size is X 1/2.

The ring contains:

Nine channel set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'H'.

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 5.40 grams

Total Gemstone Weight = 0.15ct

Total Metal Weight = 5.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
